Introduction

East Colfax Community Collective is committed to protecting your privacy. This Privacy Policy explains how we collect, use, and safeguard your personal information—including your phone number—when you interact with our website or participate in our programs.

Information We Collect

We may collect personal information when you complete forms, sign up for communications, participate in our programs, or engage with us through surveys or other tools. This may include your name, phone number, email address, or other contact information.

How We Use Your Phone Number

We may use your phone number to:

- Communicate with you about our organizing programs, events, or actions.
- Share updates, reminders, and community announcements.
- Support your access to services, resources, or referrals.
- Confirm your contact details or respond to your questions.

Sharing Your Information

We do **not** sell, rent, or lease your phone number to third parties. We only share it under the following circumstances:

- **Service Providers:** We may share your phone number with trusted third-party service providers—such as communication or data-management platforms—who support our programs or website. These providers must follow confidentiality and data-protection requirements and may only use your information for the purposes described in this policy.
- **Legal Requirements:** We may disclose your phone number if required by law or if necessary to protect our rights, safety, or the rights and safety of others.

Your phone number will **never** be used for marketing, advertising, or any business purposes outside of our nonprofit organizing and communication efforts. We will not share your phone number with businesses or outside organizations for promotional use.

We use appropriate technical and organizational measures to protect your personal information from unauthorized access, use, or disclosure. However, no method of electronic transmission or storage is completely secure, and we cannot guarantee absolute security.

Your Rights
